**MWF Community- Matters Pets & Wildlife**

The autumn months are upon us. With this, we will be able to spend more time outdoors enjoying the cooler weather. This not only pertains to us. There will be an increase in activity with the wildlife in our area.

Dr. Laura Szeremi, DVM, lives in our neighborhood. Her veterinary practice specializes in small animals. On behalf of the Control Committee, Dr. Laura has graciously accepted a request to offer us some advice with concern to wildlife encounters for us and our pets. Thanks, Dr. Laura, for accepting the invitation to share your expertise and advice.

**Pets & Wildlife** by Laura Szeremi DVM

When I found a 6 foot alligator in my arena, here in Meadow Wood I knew I really had moved to Florida! Meadow Wood Farms is teeming with wildlife. Most of these fabulous creatures will never be a problem for your pets. However, knowledge is power. Describing all the wild animals in our area would fill an encyclopedia so I'm just going to highlight a few.

**Raccoons.** Raccoons may be the cute little animal that we see the most that is also the most likely to seriously harm our pets and families. I was involved in a case where a raccoon came into the backyard and the owner's dogs tangled with it. Unfortunately, the raccoon was rabid and one of the dogs later developed rabies. This dog exposed numerous people to rabies who all had to be treated.

Raccoons are the number one carrier of rabies in Florida and so far just this year 26 raccoons, including one in Marion County have tested positive for rabies. Any encounter with a raccoon should be taken seriously. In case you didn't know, due to their high incidence of rabies it is illegal in Florida to keep a raccoon as a pet. Many home owners' policies will not cover your liability if your illegal pet bites someone. I know they are irresistible, but it's safest if you & your pets only admire raccoons from a distance.

**More on Old Yeller.** No conversation about pets & wildlife is complete without mentioning outdoor cats. Most kitties aren't really domestic animals and anyone that has ever been owned by a cat understands they only include us in their lives on their own terms. Outdoor cats are a common source of human rabies exposure. Just this July 31st someone in North West Marion county (that's US!) was bitten by a cat with rabies. Vaccinate your outdoor kitties. And take any cat bite seriously, it really could be life & death. Other common carriers of rabies are bats, fox, and skunks. As a note, opossum are highly resistant to rabies and there has never been a positive rabies test in an opossum in the 20 years Florida has been tracking rabies cases.

**Cane or Bufo Toads.** These poisonous toads haven't quite reached our area, but one has been found in the county and their northern reach is currently Deland, Florida. That's close enough for concern and many of us travel to other parts of the state with our pets. Cane toads have large poison glands on their back. Licking or just mouthing a cane toad even briefly can be fatal to your pets. Any toad larger than 4 inches is NOT a native Florida species and should be avoided. If you think your pet has interacted with a cane toad rinse its mouth with water and go straight to the veterinarian. Any Cane toad sightings in Marion county should be reported to [tadpole@ufl.edu](mailto:tadpole@ufl.edu).

**Large Birds.** One group of wild animals often overlooked to be dangerous to our pets are large birds. I've lost numerous small, and some not so small patients, to birds of prey. Owls & hawks can cause serious damage to your pets. Walking them on a leash and not letting your little ones outside at night unsupervised can go a long way to preventing a tragedy.

**Snakes.** Some people love snakes and some hate them. Of the 50 species of snakes found in Florida only 6 are venomous. Many of the non-venomous snakes will actually deter and **continued on page 10.**

### Oh Deer!

Have you noticed the deer have returned to Meadow Wood Farms? For years, a glimpse of these beautiful creatures has been few and far between. It's always fun to see the photos online of the other animals that live within our boundaries: the bobcat, great owls, fox, wild turkeys and even the "wiley" coyotes. Our special equestrian community harbors many forms of wildlife and we feel privileged to live peacefully with them.

Our **Deed Restrictions** offer protection for our animal families:

All persons are prohibited from disturbing the birds and other wildlife except for fish (#26). Generally speaking, that includes everything from relocating the gopher tortoises to hunting and killing wildlife here. Sadly, we have a report of deer hunting in the MFW's area. Local residents reported this incident to the offices of the Florida Fish and Wildlife Conservation Commission and the local Sheriff. It is especially frightening also due to the close proximity of our homes and riding trails.

We are blessed to be surrounded by private farms and woods. Even though there is a need for more "No trespassing/hunting" signs, if you hunt on private property, you must obtain the landowner's permission before entering his land. "Trespassing while possessing a firearm or other dangerous weapon is a felony punishable by imprisonment up to five years and/or a fine up to \$5000." (Fla. Fish and Wildlife Conservation Commission Rules and Regulations, p. 16).

We ask everyone to be respectful of our neighbors and wildlife. Please uphold the Deed Restrictions and By-Laws to which you agreed when you purchased property here. There are locations to safely hunt. This community of Meadow Wood Farms enjoys a tranquil and peaceful lifestyle, let's keep it that way.

Proposed Changes to the Current MWF Bylaws

Date: October 12, 2017

Article IV Section 3.3b

Current Wording:

Approved by the Executive Board and bears the signatures of the Association President and Secretary, as well as all Control Committee members in agreement with the written decision.

Proposed Wording:

Approved by the Executive Board and bears the signatures of the Association President and the chairperson (or alternate chairperson) of the Control Committee.

Rationale:

The present wording requires the signatures of five (5) people. Since the action of the Control Committee must have been previously addressed and approved by the Executive Board, requiring five signatures is redundant and could create a delay in the process of addressing the issue.

It is important to recognize a backup (alternate chairperson) if the chairperson is not available.

Article IV Section 3.4a

Current Wording:

The Control Committee members must submit to the Executive Board all current frontal fencing documentation on a monthly basis.

Proposed Wording:

The Control Committee shall submit all current frontal fencing documentation at each Executive Board meeting or at any time deemed necessary by the Executive Board.

Rationale:

The Executive Board does not always meet on a monthly basis. This proposed change allows for the Executive Board to address any fencing issues that may come up between official Executive Board meetings.

Article IV Section 2. 4a.

Current Wording:

After resolution of the complaint, a communication to the complainant must be issued, as soon as possible, stating the results of the process.

Proposed Wording:

Suggest deletion.

Rationale: All Committee activity is reported in writing to the Executive Board and again at the General Meeting of the Association. The complainant is welcome to attend the General Membership Meetings to hear the findings of the Control Committee as presented in report. Two reports are sufficient to address the results of complaints.

The complainant may benefit from attending the General Meetings of the POA. Attendance has the potential of providing attendee with logical and concrete explanation of the merits of being a member in good standing of the community Association.

Recommendation 1:

Move Article IV Sec. 2. 4a. To MWF Control Committee Procedures Document.

Move G to H (Housekeeping)

G to now read:

G. a. Upon review, any action adopted by the Board of Trustees shall take precedent and be considered final.

G. b. The Board of Trustees shall respond to the complainant stating the findings.

Recommendation 2:

Control Committee Procedures Document F.

A written report shall be submitted to the MWF Board of Trustees regarding any Committee activities at each BOT meeting.

*Whenever possible*, only the designated numbers of any violations shall be used to protect the confidentiality of the parties involved.

Rationale: There are times when the Control Committee must ask for Board to direct further action. In order for the Board to do so, full disclosure is necessary. This change allows for that to happen.

The Control Committee unanimously recommends further action of the proposed changes to the bylaws and that they, as stated, be brought before the general membership of the MWFPOA.

**MWF Control Committee**

**Procedures**

1. All submitted complaints are to be designated, "Attn: Control Committee" on envelope. No complaints will be accepted by electronic means. Only those complaints utilizing the approved form, filled out in its entirety, duly signed and dated, will be considered for investigation.

2. Any complaint received as designated with number one (1) is to be delivered in accord with MWFPOA bylaw Article 11 Sec.5.6. The Secretary shall deliver the unopened mail within seventy-two (72) hours of postmark to the Committee chairperson or, if unavailable, to another Committee member. The Control Committee shall assign a number designation to the complaint in order to maintain confidentiality. Confidentiality shall be respected at all times.

3. Investigations

A. MWFPOA bylaws Article IV section 2.2: Upon receipt of a complaint any two of the three Committee members shall conduct the investigation. No Committee member shall conduct an investigation alone.

B. The investigation shall include verification of violation of the MWF deed restrictions and/or bylaws as stated in the complaint.

C. If applicable, a visual inspection of the violation shall be made by no less than two (2) members of the Control Committee.

4. Actions

A. The Committee will send out a letter to the homeowner/occupant of property stating the violation and a request to correct it within thirty (30) days.

B. The Committee will monitor the progress and effort to correct the violation.

C. If necessary, the Committee will send out a second letter, post thirty (30) days of initial letter.

D. Further course of action, as determined by the Committee, shall be discussed by its members if the violation has not been rectified post sixty (60) days of contact.

E. The President of Board of Trustees of the MWFPOA shall be kept informed of all Committee actions.

F. A written report shall be submitted to the MWF Board of Trustees regarding any Committee activities at each BOT meeting. Only the designated numbers of any violations shall be used to protect the confidentiality of the parties involved.

G. A report shall be presented to the membership during the MWFPOA general meetings.

5. Considerations

Every attempt shall be made to protect the confidentiality of the involved parties concerning any complaints. On occasion, it may be necessary to solicit assistance from the BOT either collectively or per an individual BOT member or other MWF member. The number designation shall be used whenever possible.

even eat the venomous snakes. Please don't kill harmless snakes. It would be a shame to kill that beneficial king snake that might have prevented the cottonmouth from moving in next. It is relatively easy to identify the 6 species of venomous snakes. There is a wonderful guide to the snakes of Florida done by the Florida Museum if you'd like to learn more. [www.floridamuseum.ufl.edu](http://www.floridamuseum.ufl.edu) It's even easier to simply avoid snakes. In spite of the urban legend, very few species of snakes will go out of their way to chase or attack you unless you are in Panama being chased by a Central American Bushmaster.

**Coyotes & Foxes** Six fox have tested positive for rabies so far this year in Florida, including one in neighboring Lake County. Coyotes test positive for rabies less often but interaction with coyote and pets are becoming more common. They are losing some of their fear of people and most pets attacked by coyotes occur at night, dawn or dusk. Keeping your pets on leashes and supervising outside time will go a long way to avoiding a coyote interaction. If a coyote approaches you or your pets they are still easily scared away by noise or movement.

As I was writing this I realized I could go on for days, so I will wrap it up here. I hope you've enjoyed this tour of pets & wildlife. I'm happy to answer questions and I'm even happier to be living in this wonderful community. Laura Szeremi DVM

PUMPKIN PIE (a la easy, a la best) edit 112017  
Antionette Kimball

1 can pumpkin (small - 15 oz.) 2 eggs

1 can, 14-oz Eagle Brand sweetened, condensed milk

2 t. cinnamon , 1 t. nutmeg , 1 t. ginger , 1/2 tsp. ground cloves

9" pie shell (I usually use graham cracker crust!)  
(optional!!)

I beat the eggs first, then add 1/2 can pumpkin to the eggs.  
Then add the spices to the other 1/2 can of pumpkin and  
mix well, then mix into the eggs.

Last add the milk, 1/2 can at a time. Pour into shell and  
bake at 375 for 50 min. (I turn oven off at 40 min and leave  
for 10 min more)

It has only 4 ingredients, so I can remember this recipe!  
(generic pumpkin ok, Aldi's brand is very good!)

Ever since I found this recipe, I have not made pumpkin  
pie any other way. I believe it to be Eagle Brand's own  
original recipe, except I doubled the spices and added the  
ground cloves. (recipe found in the coupon ads!) Right  
out of the oven, this pie can be sliced. It comes out perfect  
all of the time. I even make it now, with NO crust! I call it  
Pumpkin Pie-less. (Less calories). I hope you will try it. It  
has only 4 ingredients, so it is also easy to remember!!!
