General Meeting Minutes November 16, 2021

Present: President Jim Thomas, Vice President Marilee McGinnis. Absent: Treasurer Karen Reade, Secretary Jenny Adams

- I. President Thomas called the meeting to order at 7:00 p.m.
- II. President Thomas called for new members, and welcomed residents from 62 Never Bend Dr and 67 Lake View Dr. East.
- III. President Thomas received a motion to approve the minutes from the last General meeting as posted on the web site. Motion was seconded and passed.
- IV. President's Report: President Thomas reported several phone calls on issues which the Association cannot deal with, and he referred them to the proper agencies to handle.
- V. Vice President's Report: Vice President McGinnis stated that Meadow Wood Farms had a successful drive to raise funds for Alzheimer's research.
- VI. Treasurer's Report: Treasurer Reade sent in her report. She states that we have \$11,669.69 in the bank, enough for about 11 months of fixed expenses. Besides the normal duties, she has begun to investigate the costs of online newsletters and directories. For a password protected program, they run upwards from \$50.00/month plus fees. It would be possible to recoup some expenses through advertising on these sites.
- VII. Secretary's Report: Secretary Adams had no report.
- VIII. Committee Reports:
 - a. Control: No new issues have been reported.
 - b. Activities: Carolyn Camp reported
 1. The Veterans and First Responders Bar B Que was a success. She thanked and praised Frenchie for her work. About 80 people attended. We do not have a final cost, but we raised more than the costs. Bob Coveney raised \$225 to donate to the USO.

- X. New Business:

He stated that it would be more comfortable to be inside in the winter months. He also stated that holding the meeting by Zoom, as the Executive Board meets, is untenable due to the meeting size. He made a motion to meet in the church for the January meeting, it was seconded, discussed at length, and passed.
